PREVENTION AND PREVENTION
CORONA VIRUS DISEASE 2019
ON CHRISTMAS OF 2021 AND NEW YEAR OF 2022

MINISTER OF HOME AFFAIRS,

In connection with the implementation of Christmas Day on December 25, 2021 and New Year's Holiday on January 1, 2022 during the pandemic *Corona Virus Disease* 2019 (COVID-19), in this regard it is instructed:

- To : 1. Governor; and
2. Regent/Mayor,
- For :
- FIRST : During the period of Christmas Year 2021 and New Year's Year 2022 (Nataru) on December 24, 2021 to January 2, 2022:
- a. activate the optimization of the functions of the COVID-19 Handling Task Force in each environment, both at the provincial, district/city, sub-district, sub-district and village levels as well as the Neighborhood Association (RT)/Rukun Warga (RW) no later than December 20, 2021;
 - b. implementing stricter health protocols (prokes) with a 5M approach (wearing masks, washing hands with soap/*hand sanitizer*, maintain distance, reduce mobility, and avoid crowds) and 3T (*testing, tracing, treatment*) and consider ventilation, air, duration and distance interaction factors to reduce the risk of transmission in activities;

c. do:

1. accelerate the achievement of vaccination targets in their respective regions, for the first dose to reach the target of 70% (seventy percent) and the second dose to reach the target of 48.57% (forty eight point fifty seven percent) of the total target, especially vaccination for the elderly until the end of December 2021; and

2. start vaccinating children aged 6 (six) years to 11 (eleven) years provided that the target has reached a minimum of 70% (seventy percent) of the first dose of the total target and a minimum target of 60% (sixty percent) of the first dose of the elderly according to with applicable regulations,

d. coordinate with the Regional Leadership Coordination Forum (Forkopimda) and other stakeholders including Religious Leaders, Community Leaders, Community Organizations, Hotel Managers, Tourist Places Managers, Shopping Center/Mall Managers and Business Actors and other parties deemed necessary according to the characteristics of each region in the context of prevention and enforcement of discipline in accordance with the provisions of the legislation;

e. do:

1. tightening the flow of inbound travelers from abroad including Indonesian Migrant Workers (PMI) in anticipation of the Nataru homecoming tradition; and

2. multiply use and maximizing application and enforcement of PeduliProtect at places of public activity such as public facilities, entertainment facilities (shopping centers and restaurants), tourist attractions, and worship facilities;

f. carry out tightening and monitoring of health protocols in places that have the potential for crowding, including: 1. Churches/places that function as places of worship during the 2021 Christmas celebrations;

2. shopping areas; and

3. local tourist attractions,

g. limiting community activities from 24 December 2021 to 2 January 2022:

1. including arts, culture and sports that can potentially cause transmission of COVID-19 carried out without spectators; and
2. which is not a Christmas and New Year celebration and causes a crowd, is carried out with health protocols and is attended by no more than 50 (fifty) people,

h. closing all squares on December 31, 2021 until January 1, 2022;

i. perform engineering and anticipate the activities of street vendors in the center of the crowd in order to keep the distance between traders and buyers;

j. people who travel outside the region, then:

1. optimize use application CareProtect;

2. meet the requirements for long-distance travel using public transportation: a. mandatory 2 (two) vaccines and perform Rapid Antigen Test 1 x 24 hours; and
b. for people who have not been vaccinated and people who cannot be vaccinated for medical reasons, long distance travel is prohibited,

3. The technical requirements for long-distance travel using public transportation are further regulated by the Task Force National COVID-19 Handling; and

4. in the event that a traveler as referred to in number 2 (two) who is positive for COVID-19, then performs self-isolation or isolation in a place that has been prepared by the Government to prevent transmission, with isolation time according to health procedures as well as tracing and quarantine of contacts. closely,

k. all levels of the Regional Government including the Civil Service Police Unit (Satpol PP), the Community Protection Unit (Satlinmas) and the Regional Disaster Management Agency (BPBD), as well as the Fire Department to increase preparedness and active involvement in:

1. preventing and overcoming public activities that may disturb the peace and public order; and

2. prevent and overcome activity mass gatherings/crowds in public facilities, entertainment facilities (shopping centers and restaurants), tourist attractions, and worship facilities, during the Nataru Holiday period.

SECOND

- : Special:
- a. the implementation of worship and commemoration of the 2021 Christmas Day will be further regulated by the Ministry of Religion; and
 - b. the implementation of the distribution of report cards for semester 1 (one) and school holidays are further regulated by the Ministry of Education, Culture, Research and Technology.

THIRD

- : Especially for the implementation of the 2022 New Year Celebration and shopping/mall places:
- a. the celebration of the New Year 2022 should be carried out individually/with family as much as possible, avoiding crowds and travel, as well as carrying out activities in their respective environments that do not have the potential to cause crowds;
 - b. prohibiting new year's parades and processions as well as banning events *Old and New Year* whether open or closed which has the potential to cause a crowd;
 - c. using the PeduliLindung application at login (*entrance*) and exit (*exit*) from malls/shopping centers and only visitors with the green category are allowed to enter;
 - d. negate *events* Nataru celebrations at Shopping Centers and Malls, except for UMKM exhibitions;
 - e. extend the operating hours of Shopping Centers and Malls which were originally 10.00 – 21.00 local time to 09.00 – 22.00 local time to prevent crowds at certain hours and carry out restrictions with the number of visitors not exceeding 75% (seventy five percent) of the total capacity of Shopping Centers and Malls and implementation of stricter health protocols; and
 - f. eating and drinking activities in shopping centers/ malls can be carried out with a maximum capacity limitation of 75% (seventy five percent) with the implementation of stricter health protocols.

FOURTH

- : Specifically for tourist spot arrangements:
- a. increase awareness of tourist attractions, especially for areas as favorite tourism destinations, including: Bali, Bandung, Bogor, Yogyakarta, Malang, Surabaya, Medan, and others;
 - b. identify tourist attractions that are the target of holidays in each district/city in order to have good health protocols;
 - c. apply odd-even arrangements to organize visits to priority tourist attractions;
 - d. continue to apply stricter health protocols with the 5M approach (wearing masks, washing hands with soap/*hand sanitizer*, maintain distance, reduce mobility, and avoid crowds);
 - e. increase socialization, use and enforcement of *PeduliLindungi* and *PeduliProtect* at the time of entry (*entrance*) and exit (*exit*) from tourist attractions and only visitors with the green category are allowed to enter;
 - f. ensure that there are no crowds that could result in an inability to maintain a distance;
 - g. limit the number of tourists to 75% (seventy five percent) of the total capacity;
 - h. prohibit celebratory parties with crowds in open/ closed areas;
 - i. reduce the use of loudspeakers that cause people to congregate in large numbers; and
 - j. limiting community activities including cultural arts that cause crowds that have the potential to spread COVID-19.

FIFTH

- : Matters that have not been regulated in this Ministerial Instruction related to the Prevention and Control of COVID-19 at Christmas 2021 and New Years in 2022 can be regulated by the Regional Head in accordance with the COVID-19 pandemic situation in their respective regions with the principle of restrictions that apply. tightened to prevent a spike in COVID-19 due to community activities celebrating Nataru.

SIXTH : This Ministerial Instruction shall come into force on December 24, 2021 until January 2, 2022 and at the time this Instruction of the Minister of Home Affairs takes effect, the Instruction of the Minister of Home Affairs Number 62 of 2021 concerning Prevention and Control *Corona Virus Disease 2019* At Christmas Year 2021 and New Year's Year 2022 are revoked and declared invalid.
